III.A. Resolution 2018-4 - National Incident Based Reporting System Council may recall that one approach to partial fund the upgrade in Police Department operational software was to apply for grant funds made available under this program and geared toward departments whose current software systems were not compliant. As the system selected and now installed is compliant, request for these funds can be made. Submission requires this authorization by the governing body to guarantee that system and upgrades will be made if awarded. All needed upgrades have already been installed so no additional expenditures are being authorized by this action. Staff recommends approval.

III.B. Approve Change Order #3 - TWDB Contract for Sewer Improvements with **Doughtie Construction**

This is the final change order for this project. Bob Staehs will be available to answer any specific questions on this change or the pending close out of this project that is very nearly complete. This is the final change inclusive of all construction items. Total project costs are increased to accommodate the actual pipe linear footage for rerouting along Wooley and Greer streets from the creek bottom to avoid condemnation as well as add five manholes for connections of unidentified/unknown service line connections. Without these line changes, the old main from Riggs to the Pate Pasture lift station couldn't be abandoned, posing a significant likelihood of stormwater infiltration and inflow (I&I) into the system during rain events, which is the primary reason this project was undertaken. This change does increase the final project costs by \$50,408.27 which does put this project slightly over the original budget. Funds remain available within the utility capital improvement budget since the grant was not received to proceed with the elevated storage tank project this year. Staff concurs with the engineer that this change warrants approval and necessary improvements.

III. C. Shelby County Chamber Request to Host Grill-Fest on the Downtown Square Attached is a request to host an event on the downtown parking surrounding the courthouse square similar to What-a-Melon and Poultry Festival. Staff has attempted to meet with this event committee to evaluate the hours and primarily control of alcohol which historically accompanies this event. While the date doesn't pose a conflict with anything already scheduled, there are several potential aspects of the event that pose problems with this location request relative to current local and state laws, most notably related to the possession and consumption of alcohol on the public square. Permission of the Council would be sufficient to authorize exceptions to local regulations impacting the overnight hours of event operation. The question of alcohol-related events has come up at least one time prior with Council allowing an event but not authorizing any alcohol. Council regulations and state law prohibit the public consumption and open containers. The Chief has detailed concerns with state law and potential necessity of enforcement. If approved, based on state law and historic precedent, it is the recommendation that so as not to conflict with state law, permission for this event not include any authorization related to alcohol.

- A. Dixie Youth Baseball Regional World Series
 As this has so many additional impacts and attention, I will likely leave it as
 an item for potential discussion until July.
- B. Street Construction Drewery Construction contact currently working on 6-7 roads including Wooley, Garrett, College, Riggs, John C Rogers and Rainbow. Finish paving should commence soon but has been delayed substantially by both weather and most recently a large water line repair.
- C. Utility Construction we have had several calls of the phone, fiber and gas company installations in town at many locations. If problems are reported, please let staff know so that the contractors can be notified and advised.

RESOLUTION 2018-04

A RESOLUTION OF THE CITY OF CENTER AUTHORIZING THE CITY MANAGER TO APPLY FOR JUSTICE ASSISTANCE GRANT FUNDS FROM THE OFFICE OF THE GOVERNOR, CRIMINAL JUSTICE DIVISION, FOR THE CENTER POLICE DEPARTMENT'S CONVERSION TO THE NATIONAL INCIDENT-BASKED REPORTING SYSTEM (NIBRS).

WHEREAS, The Center City Council finds it in the best interest of the citizens of Center, that the Center Police Department Technology Enhancement Program be operated for FY 2018; and

WHEREAS, The Center City Council agrees to provide any applicable matching funds for the said project as required by the Criminal Justice Division grant application; and

WHEREAS, The Center City Council agrees that in the event of loss or misuse of the Criminal Justice Division funds, the Center City Council assures that the funds will be returned to the Criminal Justice Division in full; and

WHEREAS, The Center City Council designates the City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency.

NOW THEREFORE, BE IT RESOLVED that the Center City Council approves submission of the grant application for the Center Police Department's Conversion to the National Incident-Based Reporting System (NIBRS) to the Office of the Governor, Criminal Justice Division.

Overview

The Center Police Department seeks to apply for the National Incident Based Reporting System (NIBRS) grant that is currently being offered though the Texas Governors Office. This a zero-match grant that covers the cost for law enforcement agencies to fund activities that further the reporting of NIBRS data to DPS. Such activities include, but are not limited to, technology upgrades to existing infrastructure or the purchase of new technology that would allow for the reporting of NIBRS data. The procurement of a complete Records Management System (RMS) is eligible under this announcement.

History

In January 2018 the Center Police Department went live with eForce Software (a NIBRS reporting system) as part of the Center Police Department's technology overhaul. When seeking approval from the City Council (in November and December) for procurement of the eForce software, the Center Police Department was cautiously optimistic that there was a likelihood of being awarded this grant when it became available in 2018.

Conclusion

It is the hope of the Center Police Department that the department will be authorized to apply for, and subsequently be awarded, NIBRS Grant Funding through the Governor's Office to retroactively cover the software costs of the eForce Software System. The department is respectfully requesting the City Council's approval to apply for this grant.

REF: Public Consumption of Alcohol On City Downtown Square

To: Chad Nehring, City Manager

It is my understanding that the Chamber of Commerce is requesting to move the "Grill Fest" to the downtown city square. In my opinion the move poses some legal problems for the city. In my experience Bar-B-Q cook-off teams traditionally drink alcoholic beverage while participating in these events.

In the past this event has been held at the Civic Center where alcohol can be consumed at the venue under contract with the city and with some restricted access. Moving this event to the downtown city square is in clear violation of the City of Center Code of Ordinance 6-4, Article 1 in particular Sec 6-2 section A.

If the City choses to allow this event on the square it should be on the entry form for each team that no alcohol will be allowed or tolerated and violations will result in arrest by Center PD Officers.

CODE OF ORDINANCES CENTER, TEXAS

ALCOHOLIC BEVERAGES 6-4

ARTICLE I. IN GENERAL

Sec. 6- 1. Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings

ascribed to them in this section, except where the context clearly indicates a different meaning:

Alcoholic beverages are as defined by V.T.C.A., Alcoholic Beverage Code § 1. 04.

Container means the can, bottle or carton in which an alcoholic beverage is placed for sale.

Ord. No. 78-13, § 3, 6-26-1978)

Cross reference Definitions generally, § 1-2.

Sec. 6-2. Possession, consumption in public places.

- a) The carrying on or possession of alcoholic beverages on properties owned by the city is hereby expressly prohibited.
- b) Such properties include, but are not limited to, the Community Park, the Mini Park, Perry Sampson Park, and the American Legion Park.

Ord. No. 78- 13, § 1, 6-26- 1978; Ord. No. 78- 14, §§ 1, 2, 6- 12- 1978; Ord. No. 87- 10, 5- 11- 1987)

Cross reference Streets, sidewalks and other public places, ch. 78.

State law reference Order for prohibition of consumption, V.T.C.A., Alcoholic Beverage Code § 109. 35.

Sec. 6-3. Exhibiting alcoholic beverages, discarding containers in public places.

It shall be unlawful for any person to exhibit alcoholic beverages or alcoholic beveragecontainers; discard alcoholic beverage containers on any public street, public park, public parking area or private parking area open to the public within the city; and any and all such acts are hereby declared to be unlawful and are hereby declared to be public nuisances.



To ban public drinking, a city must request approval from the TABC under §109.35 of the Texas Alcoholic Beverage Code. Even if the TABC approves this request, it is not a complete ban across the city. Instead, cities can only ban public consumption of alcohol in the "central business district" area of the city. This means that cities can only ban in locations where 90% of the buildings are commercial, so a city can't ban public drinking in other areas like a residential neighborhood



What are the legal hours of public consumption of alcoholic beverages?

In an extended hours area, a person may not consume or possess with intent to consume an alcoholic beverage in a public place:

- Monday-Saturday: before 7am or after 2:15am
- Sunday: before noon or after 2:15am

- Exception: Consumption is legal between 10am and noon on Sunday:
- At an on-premise establishment when it is sold along with the service of food to a customer;
- At a winery, fair, festival, concert, or sports venue.
 "Extended hours area" means an area subject to the extended hours of sale provided in Section 105.03 or 105.05 of this code.

In a standard hours area, a person may not consume or possess with intent to consume an alcoholic beverage in a public place:

- Monday-Friday: before 7am or after 12:15am
- Saturday: before 7am or after 1:15am
- Sunday: before noon or after 12:15am
- Exception: Consumption is legal between 10am and noon on Sunday:
- o At an on-premise establishment when it is sold along with the service of food to a customer;
- At a winery, fair, festival, concert, or sports venue.
 "Standard hours area" means an area which is not an extended hours area.

Sec. 109.35. ORDERS FOR PROHIBITION ON CONSUMPTION. (a) If the governing body of a municipality determines that the possession of an open container or the public consumption of alcoholic beverages in the central business district of the municipality is a risk to the health and safety of the citizens of the municipality, the governing body may by charter or ordinance prohibit [petition for the adoption of an order by the commission that prohibits] the possession of an open container or the public consumption of alcoholic beverages in that central business district.

(b) If a municipality prohibits [submits a petition for an order of the commission to prohibit]
the possession of an open container or the public consumption of alcoholic beverages in the central

business district of the city, the municipality must adopt [and attaches to the petition] a map, plat, or diagram showing the central business district that is [to be] covered by the prohibition[, the commission shall approve and issue the order without further consideration unless the commission finds that the map, plat, or diagram improperly identifies the central business district].

- (c) The municipality's charter or ordinance [commission's order] may not prohibit the possession of an open container or the consumption of alcoholic beverages in motor vehicles, buildings not owned or controlled by the municipality, residential structures, or licensed premises located in the area of prohibition.
- (c-1) In accordance with Section 1.06, this section does not authorize municipal regulation of the possession of an open container or the public consumption of alcoholic beverages except as expressly provided by this section.
- (d) In this section, "central business district" means a compact and contiguous geographical area of a municipality in which at least 90 percent of the land is used or zoned for commercial purposes and that is the area that has historically been the primary location in the municipality where business has been transacted.
- (e) In this section, "open container" means a container that is no longer sealed.
