REGULAR MEETING AGENDA:

- III.A. Ordinance 2018-1 1 Adoption of City Limit Map This is the annual adoption of the city limit map. This map is identical to 2017 since no changes by extension, annexation or expiration of development agreements occurred this last year.
- III.B. Resolution 2018-1 Designation of Official Newspaper for City Notices State law requires the designation of the official newspaper for mandatory notices and publication. This paper must be of general circulation within the County of the entity.
- III.C. Award of Chemical Bids for Utility Operations
 The bid tab and recommendation for award is included. Due to the annual volume usage of these chemicals, they have been bid for a 12-month contract periods that contain mutual renewal clauses, thus controlling costs throughout the budget year. This year, there are slight increases for each chemical compared to prior year but these are within the expected increases during budget development for both the water and wastewater systems. Approval is recommended.
- III.D. Approve MLK Parade January 15, 2018

 Like other parades impacting traffic temporarily on state highway system,

 TXDoT requires local jurisdiction to sanction and accept temporary responsibility
 for traffic control. Council approval of this request will authorize staff to submit
 the required letter of certification and acceptance of liability to TXDoT and
 authorize public works and police department to ensure safety and required traffic
 control at the square and along the Highway 87 route to MLK Drive.

Item I. Mayor David Chadwick opened the meeting and welcomed the visitors and media.

Mayor Chadwick presented checks to the winners of the 2017 Lighted Christmas Parade.

Item II. Administer Oaths and Issuance of Election Certificates for Newly Elected Officials.

City Secretary Barbara Boyd administered the Oath to Elected Official Howell Howard for Council Member District 3.

Item III. Approval of Minutes of the Regular Meeting on November 13, 2017.

Council Member Leigh Porterfield made a motion to approve the minutes. Council Member Jerry Lathan seconded the motion. All voted in favor.

Item III. Consider Discussion and Possible Action on the following:

A. Ordinance 2017-14 Establishing Standards for Commercial Filming. City Manager, Chad Nehring stated this ordinance was drafted at the request of the Chamber as a prerequisite to garnering designation of the Governor's Office/Texas Film Commission as a "Film Friendly" community. Mr. Nehring stated this designation includes the community in the Governor's Office promotion of pre-approved fliming locations throughout the state. Mr. Nehring stated approval will allow the Chamber to proceed with obtaining the designation while not prohibiting any future modification or clarification of these local regulations. Council Member Howell Howard made a motion to approve Ordinance 2017-14 Establishing Standards for Commercial Filming. Council Member Joyce Johnson seconded the motion. After some discussion, Council Member Terry Scull made a motion to amend the ordinance, Section B subsection c to read "The City Manager may authorize waiver this fee upon proof of an organization's non-profit status or project will be of minimal or negligible impact". Council Member Jerry Lathan seconded the motion. All voted

in favor.

- B. Award of Bid McSwain Hill Tank Painting Improvements. City Manager, Chad Nerhing stated one of the items included in the capital improvement budget, funded by the 2016 bond issue, was rehabilitation of the McSwain Hill water tank on Hwy 7 toward the Pinkston Water Plant. Mr. Nehring stated this bid was developed only inclusive to the exterior repairs and does not contain any potential rehab work for the interior of the tank. Council Member Terry Scull made a motion to approve the Award of Bid for McSwain Hill Tank Painting Improvements to Cherokee Painting and Sandblasting for \$54,700. Council member Jerry Lathan seconded the motion. All voted in favor.
- C. Authorize Design/Build Contract for Entryway Signage. City Manager, Chad Nehring stated the Mayor has acquired approval of a donation toward the purpose of installation of an initial sign at Hwy 7W and Loop 500. Mr. Nehring stated this contract is for the design to be approved prior to authorization to proceed with construction on a sign for this location. Council Member Leigh Porterfield made a motion to Authorize Design/Build Contract for Entryway Signage. Council Member Randy Collard seconded the motion. All voted in favor.
- D. Appointments.
 - 1. Center Housing Authority. This item was postponed to the next council meeting.

City of Center Recreation Director, Jason Mitchell addressed the Council regarding the award of hosting the 2018 Dixie Regional World Series to the City of Center.

ORDINANCE NUMBER 2018-1

AN ORDINANCE OF THE CITY OF CENTER, APPROVING AND DESIGNATING THE CITY LIMITS MAP OF THE CITY OF CENTER; DECLARING DESIGNATED AREAS INCLUDED WITHIN THE CITY AND PART OF THE MUNICIPALITY THROUGH EITHER DESIGNATED ANNEXATION ACTIONS OF THE CITY OR RECEIVING LONGSTANDING TREATMENT.

WHEREAS, the City of Center has existed since its incorporation prior to 1900; and,

WHEREAS, throughout the history of this incorporated City there have been numerous annexations of properties into the corporate limits; and,

WHEREAS, it is presumed that those receiving City services at "in-City" rates, paying city taxes and/or being listed on the City voter registers lists, in excess of 20 years designates inclusion in the City; and,

WHEREAS, it is required that the City periodically adopt a map depicting its corporate boundaries; and,

WHEREAS, Chapter 41 of the Local Government Code denotes the requirements of the official corporate map and the inclusion of areas within those corporate limits;


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CENTER, TEXAS, THAT;

- 1. The City Limits map for the City of Center is official declared as attached hereto.
- 2. The City Limits map adopted hereby is required to be stamped and sealed by the City Secretary as the official map of the City of Center for all purposes until repealed or amended by future official action of the City Council of the City of Center.
- 3. In compliance with Section 41.003 of the Local Government Code, areas receiving historic or longstanding treatment as part of the municipality are included in the official map and the City Council hereby finds and determines:
 - a. The tax, voter and/or utility records of the City indicate that all properties not referenced by specific annexation have been provided services and rights as if included in the City for the preceding twenty (20) years; and,
 - b. There have not been any judicial determinations or any pending lawsuits challenging these properties location within the City boundaries.
- That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

- 5. That the City Secretary is hereby ordered and directed to cause this ordinance to be published.
- **6.** That this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect upon its adoption and publication.

DETCOG Accepting Applications for Solid Waste Grants

The Deep East Texas Council of Governments (DETCOG) is now taking applications for funding of Solid Waste Projects for FY 2018/FY 2019. DETCOG anticipates awarding grants totaling \$65,000.00 in FY 2018 and \$65,000.00 in FY 2019 for a combined total funding amount of \$130,000.00.

The grants are available to Cities, Counties, Public Schools, School Districts, River Authorities as well as General and Special Law Districts with the authority and responsibility for water quality protection or municipal solid waste management. The applicants must be located within Angelina, Houston, Jasper, Nacogdoches, Newton, Polk, Sabine, San Augustine, San Jacinto, Shelby, Trinity and Tyler counties to be eligible to apply. Funding for the DETCOG Solid Waste Grants comes from the Texas Commission on Environmental Quality (TCEQ).

Applications for projects in the following categories will be accepted: Local Enforcement, Litter and Illegal Dumping Cleanup and Community Collection Events, Source Reduction and Recycling, Local Solid Waste Management Plans, Establishment of Citizens' Collection Stations and "Small" Registered Transfer Stations, Household Hazardous Waste (HHW) Management, Technical Studies, Educational and Training Projects, and other projects not included in these categories which meet TCEQ criteria.

Included for consideration during the funding will be a minimum of eight (8) Individual grants, not to exceed \$16,250.00. Each application will be judged by the DETCOG Regional Solid Waste Advisory Committee (SWAC) in accordance with the SWAC Project Review and Scoring Guidelines and DETCOG's Regional Solid Waste Management Plan.

Detailed application packets are <u>available beginning December 4, 2017</u>. Project applications are <u>due</u> to DETCOG by 4:30 p.m. on January 31, 2018. Projects are to begin approximately March 1, 2018 and end no later than July 31, 2019.
