REGULAR MEETING AGENDA:

III.A. Resolution 2018-5 – TX Water Development Board Project Completion This action is similar to other construction projects final payment but since it involved TX Water Development Board financing, a more formal resolution is required. This includes all final payments and releases retainage due the contractor to settle the contract for this construction project and establishing the warranty period. The Tx Water Development Board has already conducted their site inspection for work planned, contracted and completed under the terms of the financing and issued their final report allowing for disbursement upon contract closure. Staff concurs with the project engineer's recommendation for completion by approval of this resolution.

III.B. Resolution 2018-6 - Fair Housing Month

This is an annual formality that allows submittal and retains eligibility for several US HUD programs and applications directly or sponsored by the City. This does not obligate the City to any enforcement of housing disputes or obligate any applications for projects. Staff recommends approval.

III.C. Resolution 2018-7 - AEP-SWEPCO Base Rate Filing

This most recent rate filing was mandated for submittal by the PUC of TX upon the effective date of the revised Federal tax laws lowering the corporate income taxes on utilities this year. The filing as presented institutes an immediate interim rate, pending PUC review and final approval, amounting to savings for all customer classifications. This resolution is not approving the final rate, but suspends the City's ruling for 90 days, giving the PUC time to review and finalize a system-wide rate. This action does however adopt the presented rate as an interim rate so that it will begin being applied to customer bills immediately. Staff concurs with the request of AEP-SWEPCO to adopt this resolution suspending the rate filing for 90 days and authorizing the filed rates on an interim basis.

- III.D. Change Order #2 with Pipe Works WWTP Aeration Basin Contract The contractor on this project has not been responsive to several items of work nor responsive to several requests for alternative system installation in a timely manner. With the condition of the aeration system at the WWTP, staff has been working with the project engineer to adapt several approaches to the final installation product that would be easier for the contractor as well as more serviceable for future maintenance. The design called for bottom mounted installation in each ring of an operating aeration basin. An alternative approach of skid-mounted equipment that could be lowered (and removed) from each basin would be advantageous to the City long-term and the contractor for ease of installation. It is hoped that a final change order to adjust this contract to this approach will be negotiated and achieved prior to Monday night's meeting. While we typically wouldn't include an item without this information in advance, the condition of the plant necessitates and some level of heightened urgency. We hope to have sufficient information by Monday to explain and allow Council to act upon.
- III.E. Authorize Emergency Expenditure and Budget Adjustment WWTP Renovations Supplemental Aeration Basin Construction Contract This item is a follow through on the installation alterations and anticipated adjusts to the prior item for the improvements at the WWTP aeration basin. This item will be approval of two authorizations. First, is declaiming the emergency for timing purposes allowing for the direct contracting with a local construction company rather than a formalized bid process. Second, is allowing for the budget adjustment for a supplemental contract on this activity. The WWTP capital improvement budget currently has sufficient funds available and already appropriated to cover this level of increased costs, but the overall amount of the needed increase is dependent on the completion of the prior item. Staff and/or the project engineer can provide additional information at the meeting but as stated above, this original project contractor has been reluctant to provide cost changes for adapting the project as needed. This authorization, upon the removal of several items from the original contract with PipeWorks, would allow this supplemental contractor to complete the work. This item is completely dependent upon resolving prior item "D". If "D" is approved, this item can be considered or possibly approved contingent to the finalization of the item "D" contract changes.
- III.F. Budget Adjustment Drainage Improvements at Center Park

 There have been multiple complaints, conditions and one formal injury claim
 resulting from drainage its resulting impacts on sidewalks at the northern portion
 of Center Park closest to the football field and Moffett campus. The engineer's
 report details the drain routing problems as previously noted in prior engineer's
 report. Now that those problems have resulted in two wash-out areas and one
 section of sidewalk failure from undermining, we have prepared a budget change
 and recommendation along with construction quote to make some immediate

repairs to remedy current situations and hopefully prevent some continued physical damages. These are similar improvements that have previously been requested to accommodate off-site drainage to these locations. If approved, the funds will be allocated from City budget for these necessary improvements and staff will proceed with ensuring these improvements according to the included estimate.

III.G. Design Proposal for Soccer Complex

Enclosed is a design project to develop plans for soccer filed installation at Community Park on Ballard St. These activities were allocated initial funding within the Capital Project budget this year and developed from the Parks Master plan. This would be the first expenditure of these funds and while it is budgeted, staff felt it appropriate to have Council authorize proceeding at this point with the planning since the funding allocated is estimated to be insufficient for immediate construction.

A construction contract final inspection was conducted on March 22, 2018. At the time of the final inspection, all work appeared to be complete and in accordance with the plans and specifications. There was some erosion on the north bank at the new Gilchrist lift station. Due to recent wet weather, the contractor was not able to address this item. It will be treated as a warranty item.

Three change orders were issued for this contract which increased the contract amount by \$136,203.33 for a current contract amount of \$2,289,526.88. A final quantity adjustment change order is expected to be issued.

The one-year warranty start date will be established when the City accepts the contract as complete.

The contractor installed approximately 14,300 LF of 8- to 20-inch sanitary sewer pipe, 17,600 LF of 14-inch force main, and a new lift station. Five existing lift stations were modified to act as manholes and send influent to the new lift station. The new Gilchrist lift station was put online in December of 2017. The engineer, Mr. Bob Staehs, P.E. and Mr. Marcus Camero from the City both stated that the lift station and collection lines were working as satisfactorily.

RESOLUTION 2018-07

A RESOLUTION OF THE CITY OF CENTER FINDING, AFTER REASONABLE NOTICE AND HEARING, THAT SOUTHWESTERN ELECTRIC POWER COMPANY'S PROPOSED BASE RATE REDUCTION SHOULD BE ADOPTED ON AN INTERIM BASIS, AND THAT ITS APPLICATION SHOULD BE SUSPENDED AS PROVIDED BY LAW.

WHEREAS, PURSUANT TO §33.001 OF THE Public Utility Regulatory Act, the city of Center has exclusive, original jurisdiction over the electric rates, operations and services provided within city limits by Southwestern Electric Power Company (SWEPCO or the Company).

WHEREAS, on April 5, 2018, SWEPCO filed with the City of Center, a Petition and Statement of Intent seeking an overall net decrease of 4.9% in total non-fuel revenues.

WHEREAS, the Company proposed an effective date of May 10, 2018.

WHEREAS, SWEPCO requested that the City suspend its application as provided by law, and the Company further requested that the City approve the proposed rate reduction on the interim bases during the suspension period, subject to refund or surcharge consistent with the final approved rates.

WHEREAS, SWEPCO requested an effective date for the interim rate reduction of May 14, 2018, or such other date as is consistent with the effective date for the interim rates ordered by the Public Utility Commission of Texas.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CENTER, TEXAS:

SECTION 1. It is hereby found an determined that said meeting at which this Ordinance/Resolution was passed was open to the public, as required by Texas law, and that advance public, as required by Texas law, and that advance public notice of the time, place and purpose of said meeting was given.

SECTION 2. Pursuant to the authority granted in section 36.109 of the Public Utility Regulatory Act, SWEPCO's request for approval of its base rate reduction is approved on an interim basis during the suspension period established in Section 3, with an effective date of May 14, 2018, or such other effective date that coincides with the effective date for interim rates ordered by the Public Utility Commission of Texas.

SECTION 3. SWEPCO's application to change rates is suspended for the maximum period authorized by section 36.108(a)(1) of the Public Utility Regulatory Act. During the suspension period, the interim rates established in Section 2 shall be observed, subject to refund or surcharge as necessary to be consistent with the final approved rates. The base rates set forth in this Ordinance/Resolution may be changed and amended by either the City or the Company only as provided by law.

SECTION 4. This Resolution shall be served on SWEPCO by U.S. Mail to the Company's authorized representative, Henry C. Steele, 400 West 15th Street, Suite 1520, Austin, Texas 78701.

SECTION 5. Nothing contained in this Resolution shall be construed now or hereafter as limiting or modifying, in any manner, the right and power of the City under law to regulate the base rate and charges of SWEPCO.

SWEPCO is proud of its community partnership and the opportunity to serve your residents and businesses for more than 100 years. The economic vitality of each of the communities SWEPCO serves benefits from a dependable supply of electric power at a reasonable cost.

SWEPCO is making a rate reduction filing with all its municipalities exercising original rate setting authority and with the Public Utility Commission of Texas (PUC) on April 5, 2018. The filing is made pursuant to Section 36.102 of the Public Utility Regulatory Act, in order to comply with the requirements of the final order of the Public Utility Commission of Texas in SWEPCO's last base rate case, Docket No. 46449.

SWEPCO is making this filing to reduce its base rates, in order to reflect the impact of the recently adopted federal law lowering the corporate income tax rate. SWEPCO estimates that its overall annual revenue requirement will decrease by approximately \$18 million upon approval by municipalities and the PUC of this filing.

If your municipality has ceded its original rate-setting jurisdiction to the Commission, this information is being provided to you as a courtesy and you do not have to take any further action.

For those cities that have retained original jurisdiction over SWEPCO's retail electric rates, further action sought by SWEPCO is explained below. As has always been the case, SWEPCO is committed to working with local and state officials to ensure the timely construction and maintenance of a strong and robust generation, transmission and distribution system. ACTION REQUIRED BY MAY 10, 2018

Action is required by your City as a regulatory authority which has retained original jurisdiction to review and act on SWEPCO's requested change in base rates. SWEPCO is making this filing, consistent with the directions of the Public Utility Commission in SWEPCO's most recent base rate case, to reduce its rates so that they are consistent with recent changes in federal law which reduced the corporate income tax rate.

Your City's exercise of its regulatory authority is governed by the Public Utility Regulatory Act, commonly referred to as "PURA." PURA provides for a municipal regulatory authority to take initial action on SWEPCO's rate request within 35 days after the case is filed. SWEPCO requests that you take the following actions, which will support SWEPCO's efforts to put the rate reduction in place for the benefit of its customers as soon as reasonably possible:

- Approve SWEPCO's request to put the rate reduction in force on an interim basis, effective May 14, 2018 (or, in the alternative, on the same date that the Public Utility Commission makes interim rates effective); and
- 2) "Suspend" SWEPCO's application for an additional 90 days (a total of 125 days) in order to provide additional time before taking final action.

A draft municipal ordinance designed for the purpose of implementing these two initial actions is attached for your consideration.

The deadline under PURA for your city to take these actions is May 10, 2018. SWEPCO needs for all of its municipal regulators, and the Public Utility Commission, to act in a coordinated fashion by this deadline to establish interim rates and suspend its application. In this way, the rate reduction will be applied on a uniform, system wide basis to all of SWEPCO's Texas retail customers.

Approving the rate reduction on an interim basis and suspending the application is only the first step in the process to approve the rate reduction. Once SWEPCO is able to obtain certainty as to the action the Public Utility Commission will take on its application, it will return to all of its cities exercising original jurisdiction for <u>final</u> approval of the reduction within the city limits of those cities.

The interim rates SWEPCO asks you to approve are just that; they are designed to be implemented quickly, so that customers will receive the benefit of the rate reduction as soon as reasonably possible. The rates finally approved by the Public Utility Commission will supersede the interim rates, and if the final rates approved by the Commission are different from those approved on an interim basis, SWEPCO will be required to "true-up" the final rate so that it is as if customers were billed the correct final rate from the very outset of the regulatory process.

In order to support timely reduction of SWEPCO rates to the benefit of all Texas customers, SWEPCO requests that your City Council take action to adopt the attached draft municipal ordinance by May 10, 2018.


